### **ODMH-ODADAS Consolidation Update**

The process of creating a new state department from the Departments of Mental Health and Alcohol and Drug Addiction Services continues to progress on several fronts. The *Consolidation Survey*, which gathered input from 1,374 stakeholders, provided insight on priorities, concerns and expectations for the new department and the work of the next 10 months. Overall feedback found general agreement with the consolidation goals to: improve access to more timely, effective services; support better client outcomes; reduce unnecessary regulatory burden on behavioral health providers and local administration, while improving overall accountability; implement a combined agency culture rooted in transparency, communication, inclusion and employee buy-in.

Workgroups being overseen by the Office of Health Transformation will undertake the lion's share of the work over the next few months leading up to budget submission to the Ohio Office of Budget and Management. Participation in the workgroups is open to consumer and family groups, state departments, county ADAMH boards, service providers, and numerous partner organizations, both state and local. The nine workgroups are: Evaluation, External Relations/Client Involvement, Fiscal Operations, Prevention, Provider Regulation, State-Local Relationships, Treatment and Community Supports, Workforce Development and Parking Lot/Implementation Teams. ### **Kasich Administration Announces Next Steps to Modernize Medicaid**


Plans Underway to Make Ohio Medicaid a Stand-Alone Cabinet Agency

The Kasich Administration recently announced plans to transform Ohio Medicaid into its own state agency, eliminating it as a division of the Ohio Department of Job and Family Services. Ohio Medicaid, also known as the Office of Ohio Health Plans, would become its own department July 1, 2014. # Ohio Announces New Tool to Help Fight Rx Painkiller Diversion, Abuse and Addiction "Biometric Enrollment and Verification Rx System Pilot Project" Unveiled at Gallipolis Medical Center

The Governor's Office of Health Transformation and ODADAS joined with State Sen. Bob Peterson (R-Sabina) and State Rep. Ryan Smith (R-Bidwell) on July 26 to announce the Biometric Enrollment and Verification Rx System pilot program designed to reduce the diversion and misuse of prescription medications. Other partners in the project include Holzer Health Systems and CrossChx located in Gallia County.

Holzer Health Systems patients receive a fingerprint scan before seeing doctors, and several pharmacies are using the scans for patients filling prescriptions. Once the fingerprint is scanned, the data is instantly uploaded to the patient's electronic medical record. The information records how many times the patient has visited the doctor and pharmacy, and have been patient as a visited the doctor and pharmacy.





### **ODADAS Signs on as Strategic Partner for National Medicine Abuse Project**

ODADAS has joined the growing list of strategic partners to support "The Medicine Abuse Project," a multi-year effort to raise awareness and curb the abuse of medicine coordinated by The Partnership at Drugfree.org. The Medicine Abuse Project, which launches the week of Sept. 23-29, brings the public and private sectors together in a national education initiative and call



to action to stop teen medicine abuse. The Office of National Drug Control Policy, Drug Enforcement Administration, National Institute on Drug Abuse, Centers for Disease Control and Prevention and the Bureau of Justice Assistance are the campaign's federal partners.

The Project will both encourage and help parents and the public-at-large to take action: first, by talking with the young people in their lives about the dangers of abusing prescription and over-the-counter medicines, and second, by safeguarding and properly disposing of unused medications. The launch week will culminate with the DEA-facilitated *National Prescription Drug Take-Back Day on September 29*, where consumers can safely dispose of their unused medications at sites around the country operated by local law-enforcement partners. # **Collegiate Prescription Drug Abuse Prevention Conference**







More than 100 students and faculty members from 27 campuses, including about a dozen Ohio schools, participated in the inaugural Collegiate Prescription Drug Abuse Prevention Conference hosted by The Ohio State University's College of Pharmacy in partnership with Cardinal Health Foundation, Drug-Free Action Alliance, The BACCHUS Network, National Council on Patient Information and Education, ODADAS, Ohio Department of Health and the NOPE Task Force. Teams of 3-5 representatives from colleges/universities gathered to learn more about prescription drug abuse among college students and resources for prevention. Teams developed "take-home plans" for an educational prevention strategy. ### **Ohio Wins Federal Recovery Supports for Behavioral Health Grant**

Ohio will receive a \$50,000 grant to grow the state's Peer Support/Recovery Coaching services, as well as to receive technical assistance through participation at a 2012 Policy Academy. The grant is a Bringing Recovery Supports to Scale Technical Assistance Center Strategy (BRSS TACS) award from the federal Substance Abuse and Mental Health Services Administration (SAMHSA) with the goal of promoting the implementation of recovery-oriented supports, services, and systems. ODMH and ODADAS collaborated with Ohio Citizen Advocates, Ohio Empowerment Coalition, ODJFS (Medicaid), and Rehabilitation Services Commission on this grant. Ohio was one of only eight states to receive the award. The grant will allow the two departments to work collaboratively through a Policy Academy to develop and implement strategies to improve the accessibility, quality, and cost-effectiveness of Peer/Recovery Services within the behavioral health system. ### **Ohio BWC Working to Reduce Painkiller Use Among Injured Workers**

### Agency Reports 12 Percent Drop in Narcotic Painkiller Use from February to April

Nearly one-third of prescriptions paid for by Ohio's insurance fund for injured workers last year were for painkillers. The state has seen a 37 percent increase in the use of such drugs among injured employees over the past 10 years. But that is starting to change for the better after the Ohio Bureau of Workers' Compensation (BWC) implemented policy changes restricting the drugs that doctors can prescribe after treatment for the initial pain that stems from an injury. In fact, from February to April this year, BWC reports a 12 percent decrease in patients who receive the most powerful narcotic painkillers. ### **Ohio AG Announces Plan to Fight Prescription Drug Thefts in Nursing Homes**

Ohio Attorney General Mike DeWine is intensifying state efforts to stop pharmaceutical drug thefts in long-term care facilities by offering investigative assistance to every nursing home, assisted living agency, and residential care facility in Ohio. The effort is in response to growing concerns over prescription drug abuse, including drug diversion (theft), by care facility employees. In many cases employees steal prescription drugs to feed their own addictions, the addictions of a loved one, or to sell the medication on the streets. The Medicaid Fraud Control Unit (MFCU) of the Ohio Attorney General's Office is authorized to review and investigate complaints of elderly abuse, neglect, and drug diversion. Along with the Office of the Long-Term Care Ombudsman and the Ohio Department of Health, the MFCU can also seek the prosecution of suspects. Anyone who suspects abuse, neglect or drug diversion in one of Ohio's care facilities can file a complaint by contacting the Medicaid Fraud Control Unit at 614-466-0722, by calling the Attorney General's Help Desk at 800-282-0515, or by filing a complaint online at www.ohioattorneygeneral.gov/Enforcement/Report-Patient-Abuse-or-Neglect.

### **OASIS Men's Therapeutic Community to Celebrate 20 Years**

The OASIS Men's Therapeutic Community at Pickaway Correctional Institute (PCI), a partnership between ODADAS and the Ohio Department of Rehabilitation and Corrections (ODRC), will celebrate 20 years of dedicated service with an anniversary open house and alumni reunion on Sept. 10. OASIS, which stands for "Our Awareness of Self Increases Success," provides intensive residential drug and alcohol treatment services to offenders incarcerated in the state prison system. The goal of the program is to address the substance abuse issues of each offender in the program, while addressing their personal issues and expectations for their successful reentry back into the community following their release from prison.

### Public Notice of Intent to Redesignate the Ohio P&A and CAP for People with Disabilities

The Governor has issued a *public notice* to redesignate the Ohio Protection and Advocacy System (P&A) and the Client Assistance Program (CAP) for people with disabilities. Each state and territory has a P&A program and a CAP. Ohio Legal Rights Service is the P&A and CAP for Ohio. Right now, Ohio Legal Rights Service is an independent state government agency. The Governor would like to change Ohio Legal Rights Service to a non-profit corporation. This change will happen on **October 1, 2012**. The agency's new name will be **Disability Rights Ohio** and will continue to provide client-directed advocacy to people with disabilities. Also, Disability Rights Ohio will be able to: work more closely with people with disabilities to decide the kind of work Disability Rights Ohio should do; be more involved in individual and systemic advocacy issues; and better meet federal requirements required by the P&A and CAP.

### **Youngstown UMADAOP Receives National Award**

ODADAS salutes the Youngstown Urban Minority Alcoholism and Drug Abuse Outreach Program (YUMADAOP) which received an honorable mention NIATx i-Award from the University of Wisconsin-Madison at the 2012 State Association of Addiction Services National Conference/NIATx Summit.

NIATx (Network for the Improvement of Addiction Treatment) is a process improvement model developed through Center for Health Enhancement System Studies, College of Engineering to improve outcomes, including cost savings and revenue using existing resources. YUMADAOP has utilized the NIATx model since the spring of 2010, resulting in a cost savings of slightly more than \$75,000 and increased revenue of \$39,000. It has also increased opportunities to provide mentoring and prevention services for students of the Youngstown City School District. YUMADAOP has served an additional 102 persons since adopting NIATx.

# Wright State University, ODMH, DODD Partner to Expand Services for Children with Disabilities and Mental Illness

In an effort to address the current gap in services for Ohio children, the Department of Developmental Disabilities (DODD) has developed an ongoing collaboration with the Department of Mental Health (ODMH) and Dr. Julie Gentile at Wright State University's Coordinating Center of Excellence (CCOE) to expand high quality services to people who experience both mental illness and developmental disabilities. The CCOE has secured the services of two additional psychiatrists who are able to accept patients with cooccurring issues under the age of 18 in addition to the current psychiatric services available to adults. Children can receive care at Wright State University's Consumer Advocacy Model (CAM) offices and, for those counties who are currently eligible for Ohio's Telepsychiatry Project,

# ED Visits for Misuse or Abuse of Pharmaceuticals More Than Doubles from 2004 to 2010

The estimated number of drug-related emergency department (ED) visits involving the misuse or abuse of pharmaceuticals increased significantly from 2004 to 2010, according to data from the Drug Abuse Warning Network (DAWN). More than 626,000 ED visits in 2004 were related to the misuse or abuse of pharmaceuticals, compared to more than 1.3 million in 2010. In 2010, approximately one-half (49%) of these pharmaceutical misuse or abuse visits involved pain relievers (both opioid and non-opioid) and more than one-third (35%) involved drugs to treat insomnia and anxiety. In contrast, the number of ED visits involving illicit drug use was relatively stable from

2004 to 2009, and then increased by 20% from 2009 to 2010. For more information, download the latest <u>Center for Substance</u> <u>Abuse Research (CESAR) Fax</u>.

### National Treatment Admissions for Opiates Other than Heroin Surpass Cocaine, Methamphetamine

The percentage of admissions to state-funded substance abuse treatment facilities citing opiates other than heroin as a primary substance of abuse continue to increase, according to recently released data from the national Treatment Episode Data Set (TEDS). Admissions for the primary abuse of other opiates, such as oxycodone, hydrocodone, and codeine, have increased steadily since 1997, from 1.0 percent to 8.6 percent in 2010 (the most recent year data are available). Opiates other than heroin are now more likely than either cocaine (8.1%) or methamphetamine (5.7%) to be cited as a primary substance of abuse by treatment clients. ### **CDC: Almost 8 Percent of Pregnant Women Report Using Alcohol**

Almost 8 percent of pregnant women report alcohol use, according to a <u>new study by the Centers for Disease Control and Prevention</u>. The study analyzed data from almost 14,000 pregnant women and more than 330,000 non-pregnant women ages 18 to 44. About one in 13 pregnant women, or 7.6 percent, said they drank alcohol within the past month, compared with 51.5 percent of non-pregnant women. The researchers found 1.4 percent of pregnant women reported binge drinking. Alcohol use among pregnant women was highest among those ages 35 to 44. The study authors note there is no safe level of alcohol use during pregnancy, which is the leading preventable cause of birth defects and developmental disabilities. Drinking during pregnancy can result in fetal alcohol syndrome and other fetal alcohol spectrum disorders (FASD), which can cause neurological problems and lifelong disabilities. ### Rapid Rise Seen in Antipsychotic Prescriptions for Children and Teens with ADHD

Antipsychotic treatment has increased rapidly among young people in the United States, with much of the increase coming from prescriptions for disruptive behavior disorders such as attention deficit/hyperactivity disorder (ADHD), Reuters reported. In the <u>Archives of General Psychiatry</u>, the researchers report that antipsychotic drugs are prescribed during almost one in three visits children and teenagers make to psychiatrists in the United States, an increase from one in 11 in the 1990s. Most of the antipsychotics are not prescribed for conditions approved by the Food and Drug Administration (FDA). In children and teenagers, antipsychotics are indicated for irritability associated with autistic disorder, tics and vocal utterances of Tourette syndrome and



bipolar mania, and schizophrenia. Researcher Dr. Mark Olfson, of Columbia University in New York, found that about 90 percent of antipsychotic prescriptions written during office visits between 2005 and 2009 were "off label," or prescribed for a condition that has not been approved by the FDA.

### **Tobacco Sales to Minors Reach All-Time Low in 2011**

Tobacco sales to minors reached an all-time low last year, under a government inspection program aimed at reducing underage tobacco use. Last year, 8.5 percent of retailers were willing to sell tobacco to minors, compared with 40 percent in 1997. The Substance Abuse and Mental Health Services Administration (SAMHSA) announced the rate is based on the results of random, unannounced checks to see if retailers would sell tobacco products to minors. The retailer checks are part of the Synar Regulations program, a federal mandate that requires states to document that the rate of tobacco sales to minors is no more than 20 percent, or risk losing millions of dollars in federal funds for alcohol and drug abuse prevention and treatment services. For the sixth year in a row, no state was out of compliance. Last year, 34 states — including Ohio (9.9%) reported less than 10 percent of retailers sold tobacco to minors. ### Web-Based "What is Recovery" Study Seeks Participants

A study funded by the National Institutes of Health is seeking people in recovery from an alcohol or drug problem to participate in a *web-based survey*. The researchers hope the study will help dispel the stigma that those in recovery face. The goal of the "What is Recovery" study is to develop a definition of recovery that reflects the wide range of people who say they are in recovery, or recovered, or used to have a problem but do not now, or are in medication-assisted recovery. Researchers hope to answer questions such as whether recovery requires abstinence, whether someone can be "in recovery" if they are still drinking or using, and if recovery is more than achieving sobriety. People participating in the study, conducted by the Alcohol Research Group, do not have to provide any personal identifying information. Answers to the web survey are confidential. Participants must be at least 18, and consider themselves as being in recovery from an alcohol or other drug addiction.

### **ODMH Announces Recipients of \$1 Million Grant for Repairs at Adult Care Facilities**

More than 100 Adult Care Facilities (ACF), which house people with various disabilities throughout the state, recently were awarded funds from a grant administered by the Ohio Department of Mental Health to make critical repairs to maintain and improve the habitability and safety of their facility. These facilities provide room, board and personal care for individuals who reside in the community, but need assistance with daily living. ODMH received 184 preapplications from eligible ACFs, and 115 have met all the requirements and will be receiving funding for one or more of their identified priorities. Eligible ACF owners applied for amounts ranging from \$2,000 to \$10,000 for each eligible facility.

In February 2012, the Ohio Housing Finance Agency (OHFA) approved ODMH to administer the \$1 million Adult Care Facility Critical Repair Grant from Ohio Housing Trust Fund to pay for health and safety repairs at Adult Care Facilities (ACFs) throughout the state.
